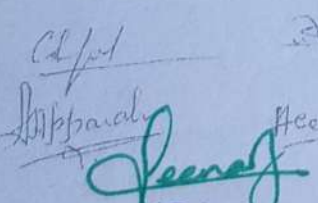

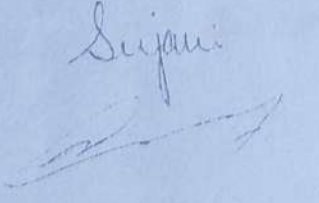

POWERS OF THE TRUSTEE:

1. The TRUSTEE/TRUSTEES shall have and may exercise all such powers as in their opinion shall enable them to effectively carry out all or any of the objectives referred to hereinabove.
2. To acquire, take on lease or invest on the corpus of the Trust Fund or any part thereof, in lands, movables and immovable properties, to hire, lease, mortgage properties and assets to let out properties and to add to the corpus of the Trust Fund and in such appropriate way as they deem fit and all such sincere actions shall not be questioned or challenged by any one.
3. The Trustee/Trustee shall have full dominion over the Trust Fund and they can manage the Trust Funds to the best of their proper judgment within the purview of statutory limits and can open, operate and close Bank Accounts in such manner as they may mutually resolve. They can borrow money for the Trust from any Individuals, Financial Institutions or such other organizations with or without securing Trust Properties. They shall apply the

5. The Routine administration of the Trust its property ad affairs, convene meetings of the Trustees, maintaining minutes, accounts, records and other documents of the Trust, shall be looked after by the sole Trustees.
6. The terms of office of the permanent Trustees shall be for life. The term of office in the case of nominated or co-opted Trustees for which for three years only, however they shall be eligible for reappointment.
7. The Trustee shall cease to be a Trustee in office with immediate effect upon his/her becoming insolvent, insane or on being convicted for involving in any offence related to moral turpitude. The Trustee shall also cease to be in office upon resignation. Any

9. The provisions of the Trust may be altered or amended by resolution passed by the Board of Trust either unanimously or with majority provided the character and object of the Trust shall not be altered. This Trust is irrevocable.

10. In the event of the determination of the Trust or in the event of the Trust failing to perform for any reason the Trustees shall make over or transfer the funds and properties of this Trust to any other Trust or institution having a similar objective which shall however be subject to unanimous resolution of the Trustee or resolution by majority.

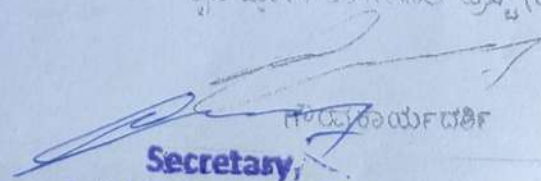
